Description

- O Discuss 3 priorities of care for the person described in the case
- Address any equity, rights and access issues relevant to the case

- You are required to write your case study responses in your own words. Do not use direct quotes.
- The template is set at 1 ½ line spacing and Calibri font size 11. Do not change the formatting.
- Each case study response should be approximately 500 words
 (3 x 500 word responses = 1500 words)

Supporting literature to answer the Case studies:

You are required to use Harvard Referencing style as per the guide provided by USC.

<u>For each response</u>, provide in text citations (references) that demonstrate you have read and referred the most appropriate information to support your response e.g. journal article, textbook, policy documents etc. You are expected to use a variety of current, credible sources in each case study response.

Reference List:

At the end of the paper you need to provide the full reference details, *in alphabetical order*, of each citation (reference) you have used in your case study responses. You are required to use the Harvard Referencing style.
